### CBSE Post Result Declaration Facilities for Class XII Students (Session 2025–26)

Dear Guardian,

This is to inform you that the Central Board of Secondary Education (CBSE) has introduced a structured mechanism for students seeking post-result facilities after the declaration of **Class XII Board Examination results for the session 2025–26**.

Students who wish to review their performance may avail themselves of the post-result facilities in the following sequence:

- **Stage I:** Students may apply for a **scanned copy of their evaluated answer book(s) of their desired subject**.
- **Stage II:** Only students who have applied for a scanned copy of their answer book(s) shall be eligible to apply for:

✚ Verification of issues observed (if any)

✚ Re-evaluation of answer(s)

*Students are advised to thoroughly examine their scanned copies with the help of the official CBSE marking scheme before applying for re-evaluation.*

#### Schedule and Revised Fee Structure

#### Important Instructions:

- The entire application process will be conducted **online only** through the CBSE portal. No offline applications shall be accepted.
- Processing charges can be paid only through online payment methods. In order to apply through school, kindly apply before **21 May 2026, 11 AM**.
- Applications submitted after the stipulated deadline will not be entertained.

- A candidate must submit only one application for a step for both one subject as well as multiple subjects. Multiple applications for the same step shall not be accepted. Once applied, no second opportunity will be accorded.
- Students applying for re-evaluation are advised to compare their answers with the official marking scheme/s and clearly mention discrepancies, if any. The marking schemes can be found at:

- Students should verify that the scanned answer book received belongs to them and contains all pages/supplementary sheets.
- Marks awarded **after re-evaluation may increase or decrease**, and even a change of one mark shall be applicable.
- The decision of CBSE in all such matters shall be final and binding.

Students and parents are requested to carefully review the guidelines and complete the application process within the prescribed timeline.
